### Main Purpose of Role

To ensure that all pallets are resorted as per Company's procedures and policies, filling in all required documentation correctly and reporting any issues to the Finish Product Manager.

## **Key Accountabilities**

- Comply with Encirc health & safety and hygiene policies, operational procedures and regulations, including wearing the relevant PPE and being correctly attired at all times.
- Document and record accurately all data related to rework activities and products
- Ensure all relevant instructions (e.g. rework requests, packing specifications, etc.) and correct procedures
  are being followed at all times when operating machinery
- Audit both live production and previous manufacturing products
- Inform the Finish Product Manager of any major defects found during rework and make a record on the rework documentation
- Be familiar with rework requests and rework record sheets, ensuring these are to be filled in correctly and neatly
- Communicate and maintain relationships with relevant stakeholders
- Ensure machines are running at correct speeds to be agreed with other teams within the production line

#### Health and Safety:

- Shall use any machinery, equipment, dangerous substances, transport equipment, means of production, or safety device provided by the employer in accordance with all training given, together with the relevant Safe Operating Procedures.
- Ensure all equipment is in good condition and safe to use prior to use, and immediately report unsafe issues to an appropriate line manager.
- All PPE should be used in accordance with the employer's instructions, and relevant risk assessment.
- Report all accidents / incidents / damages to machinery, property, and plant immediately, whether persons are injured or not.
- Maintain a good standard of housekeeping within their workplace.
- Help conduct workplace inspections, risk assessments, and to look for and recommend improvements.
