#### Main Purpose of Role

The Environmental Compliance & Assurance Specialist supports the delivery of Encirc's environmental governance, assurance, and compliance activities across all sites and business units.

Working under the direction of the Environmental Compliance & Assurance Manager, this role helps maintain the company's compliance framework, supports internal audits, tracks legal and permit obligations, and ensures timely and accurate reporting of environmental performance data.

The Specialist plays a key role in strengthening environmental assurance, providing expert technical guidance, and driving consistency across Encirc in alignment with Encirc's Zero Harm to People & Environment strategy.

#### **Key Accountabilities**

#### **Compliance Monitoring**

- Maintain and update the Environmental Compliance Framework and legal register under direction of the Manager.
- Support sites in ensuring compliance with all environmental legislation, permits, licences, and regulatory obligations.
- Track completion of statutory inspections, testing, and permit requirements.
- Review site environmental compliance documentation and identify gaps or areas for improvement.

# Audit & Assurance

- Support delivery of the internal environmental audit programme across all Group sites.
- Plan, coordinate, and assist with audit schedules, documentation reviews, and follow-up activities.
- Prepare audit summaries and assist with drafting assurance reports and improvement recommendations.
- Support third-party certification audits (ISO 14001, ISO 50001) and external regulatory inspections.

## **Governance & Reporting**

- Collate and verify environmental performance data for inclusion in dashboards, KPIs, and management reports.
- Track and monitor site-level corrective and preventive actions to closure.
- Support the development of monthly and quarterly environmental assurance reports for the Group Head of HSE and ExCo.
- Assist in identifying trends, emerging risks, and opportunities for improvement from compliance data and audits.

## **Advisory & Support**

- Provide technical guidance to site HSE teams on environmental compliance topics and documentation.
- Help interpret environmental regulations, permits, and conditions relevant to operations.
- Support development and roll-out of group environmental procedures and standards.
- Deliver awareness briefings and training sessions for site teams and new environmental leads.
